TERMS AND CONDITIONS

APPLICATION

- Rebate application must be filled out completely, truthfully and accurately. Applicant is advised to retain a copy of all applications and any accompanying documentation submitted to the Systems Building Research Alliance (SBRA) under this program. SBRA is not responsible for lost documentation.
- Funds for the rebate are limited and available on a first-come, first-serve basis. Rebate applications must be received by SBRA on or before December 20, 2010.

ELIGIBILITY

- Rebates are available only for ENERGY STAR qualified manufactured or modular homes connected to NV Energy, Inc. (formerly known as Sierra Pacific Power Company) electric service in California or Nevada.
- Only new construction qualifies. Homes must be completed at the building site no later than December 17, 2010.
- Any cooling equipment installed on the home should be properly sized per the home manufacturer's recommendations or SBRA's cooling equipment sizing guidelines for manufactured homes.
- Manufactured homes sited in Elko, Eureka and Lander counties in Nevada that have factory-installed electric resistance heat must have a maximum Uo value of 0.050. Manufactured homes sited in these counties with a Uo value greater than 0.050 must be equipped with a heat pump. In all other counties in Nevada and in California, manufactured homes using electricity as the primary heating energy source must be equipped with a heat pump.
- The applicant cannot apply for or receive rebates from any other utility or state or local program for the ENERGY STAR qualified manufactured or modular homes included in this application.

PAYMENT

- Information about the home must be entered by the home manufacturer into the SBRA ENERGY STAR Information Manager™ or the NEEM ENERGY STAR database before the rebate application will be processed.
- Payment of the rebate is conditional on verification by SBRA and/or the utility company that the home is connected to NV Energy Inc.'s (formerly known as Sierra Pacific Power Company) service.
- SBRA and/or the utility company may conduct an on-site inspection of the home to verify it has been installed (including all required heating/cooling equipment) in compliance with program requirements and completed prior to payment of the rebate.

To apply for the rebate, follow the instructions below.

- ❶ Enter the following information in the spaces below:
 - Homebuyer's name and/or the home address
 - Home Manufacturer's company name, plant city and state
 - Manufacturer's home serial number
 - Check the appropriate box to indicate if the home has gas/oil heat or electric heat
 - Check whether cooling equipment was sold with the home
 - Check if the ENERGY STAR label(s) is affixed to the home
 - Multiply the number of homes by \$500 and fill in the total expected rebate amount
- ❷ For each home, attach a copy of the following:
 - Completed and signed **Site Installation Checklist**
 - **ENERGY STAR Certificate of Compliance** (*NEEM homes only*)
 - If applicable, the cooling equipment invoice (*see item 3*)

- ❸ IF cooling equipment was sold with the home, attach a copy of the air conditioner, heat pump or evaporative cooler invoice and indicate the home's conditioned floor area in the space provided.
- ❹ Review, sign and date the **Terms and Conditions** section.
